#### Section 2: INSTRUCTIONS TO OFFERORS

Offerors are responsible for ensuring that their offers are received by Papyrus/KONBIT in accordance with the instructions, terms, and conditions described in this RFQ. Failure to adhere with instructions described in this RFQ may lead to disqualification of an offer from consideration.

- Offer Deadline and Protocol: Offers must be received no later than 5:00pm local Port-au-Prince

  Please reference the RFQ number in any response to this RFQ. Offers received after the specified
  time and date will be considered late and will be considered only at the discretion of
  Papyrus/KONBIT.
- 2. <u>Questions</u>: Questions regarding the technical or administrative requirements of this RFQ may be submitted no later than 5:00pm local Port-au-Prince time on February 7<sup>th</sup> 2017 by email to <u>expertskonbit@papyrushaiti.com</u> and cc: Melissa Padberg at <u>Melissa@papyrushaiti.com</u> Questions must be submitted in writing; phone calls will not be accepted. Questions and requests for clarification—and the responses thereto—that Papyrus/KONBIT believes may be of interest to other offerors will be circulated to all RFQ recipients who have indicated an interest in bidding.
  - Only the written answers issued by Papyrus/KONBIT will be considered official and carry weight in the RFQ process and subsequent evaluation. Any verbal information received from employees of Papyrus/KONBIT or any other entity should not be considered as an official response to any questions regarding this RFQ.
- 3. **Quotations**: Quotations in response to this RFQ must be priced on a fixed-price, all-inclusive basis, including out of pocket expenses and all other costs. Offers must remain valid for not less than thirty (30) calendar days after the offer deadline. Offerors are requested to provide quotations on their official quotation format or letterhead.
- 4. <u>Payment terms:</u> Payment will be made via wire transfer or by check. The payments will be based on deliverables.
- 5. <u>Taxes and VAT</u>: The agreement under which this procurement is financed is not exempt from the payment of taxes, VAT, tariffs, duties, or other levies imposed by the laws in effect in Haiti. Therefore, offerors must include taxes, VAT, charges, tariffs, duties and levies in accordance with the laws of Haiti.
- 6. <u>Eligibility</u>: By submitting an offer in response to this RFQ, the offeror certifies that it and its principal officers are not debarred, suspended, or otherwise considered ineligible by the U.S. Government. Papyrus/KONBIT will not award a contract to any firm that is debarred, suspended, or considered to be ineligible by the U.S. Government (or other lists).
- 7. **Evaluation and Award**: The award will be made to a responsible offeror whose offer follows the RFQ instructions, meets the eligibility requirements, and is determined via a trade-off analysis to be the best value based on application of the following evaluation criteria. The relative importance of each individual criterion is indicated by the number of points below:

- Cost Proposal—25%: The cost proposal budget should be cost effective and should maximize
  the value for monies requested in the Offeror's budget. Proposal costs should be the minimum
  necessary to adequately achieve the stated scope of work.
- **Delivery**—15%: Seller provides the most advantageous delivery schedule.
- Technical Qualifications—30%: Services shall satisfy or exceed the specifications described in RFQ/RFP Attachment A.
- Past performance—30%: Seller can demonstrate his/her capability and resources to provide the services requested in this solicitation in a timely and responsive manner.

Please note that if there are significant deficiencies regarding responsiveness to the requirements of this RFQ, an offer may be deemed "non-responsive" and thereby disqualified from consideration. Papyrus/KONBIT reserves the right to waive immaterial deficiencies at its discretion.

Best-offer quotations are requested. It is anticipated that award will be made solely on the basis of these original quotations. However, Papyrus/KONBIT reserves the right to conduct any of the following:

- Papyrus/KONBIT may conduct negotiations with and/or request clarifications from any offeror prior to award.
- Papyrus/KONBIT may cancel this RFQ at any time.

Please note that in submitting a response to this RFQ, the offeror understands that USAID is not a party to this solicitation and the offeror agrees that any protest hereunder must be presented—in writing with full explanations—Papyrus/KONBIT for consideration, as USAID will not consider protests regarding procurements carried out by implementing partners. Papyrus/KONBIT at its sole discretion will make a final decision on the protest for this procurement.

**8. Terms and Conditions**: This is a Request for Quotations only. Issuance of this RFQ does not in any way obligate Papyrus/KONBIT or USAID to make an award or pay for costs incurred by potential offerors in the preparation and submission of an offer.

This solicitation is subject to Papyrus/KONBIT standard terms and conditions. Any resultant award will be governed by these terms and conditions; a copy of the full terms and conditions is available upon request. Please note the following terms and conditions will apply:

- (a) Papyrus/KONBIT standard payment terms are net 30 days after receipt and acceptance of any commodities or deliverables. Payment will only be issued to the entity submitting the offer in response to this RFQ and identified in the resulting award; payment will not be issued to a third party.
- (b) Any award resulting from this RFQ will be firm fixed price, in the form of a purchase order
- (c) United States law prohibits transactions with, and the provision of resources and support to, individuals and organizations associated with terrorism. The supplier under any award resulting from this RFQ must ensure compliance with these laws.

## Attachment A: Scope of Work

Purpose: Local Organization Mapping

#### Context

Through its "Forward" initiative, USAID wants to use local stakeholder capacity building as an essential tool to achieve more effective and sustainable development results. Being one of the first of this type of projects, Konbit will establish a "capacity building platform" to coordinate local capacity development service provision, create a network of development innovations, and manage the monitoring, evaluation and learning activities. Konbit's objective is to increase the number of local development partners who influence and achieve significant sustainable development results in Haiti, are accountable to their constituents and are able to compete for and manage resources.

#### **Implementation**

Konbit is managed by Papyrus S.A. and its local partner Ayiti Nexus. The project is supported by two international partners: Steve Kroll and Associates and Tetra Tech, and will work with partnering service providers to:

- Build the competencies of local capacity development service providers and develop the competencies of institutions;
- Mobilize networking events to foster collaboration and sharing of good practices, innovations and industry standards in the capacity development and technical sectors.
- Measure the project's progress and results, use its monitoring and evaluation process and results to create learning opportunities for program participants, and use its interactive platform to share lessons learned.

Papyrus will work with USAID to expand upon its mapping process to inventory the broader category of local development organizations, and more specifically to identify both experienced and prospective organizational capacity development service providers, including those that are either headed by women or work specifically on gender issues.

### Description

Konbit seeks to establish a contract with a firm:

To update the existing organizational database and continue with the exercise of mapping local organizations and NGOs. This would constitute the basis on which Konbit can strengthen the engagement of local organizations to leverage resources, reinforce capacities and generate ideas for innovative joint initiatives.

**Geographical focus:** Country Wide

### Objectives of the mapping exercise

- In collaboration with Konbit staff, develop the data collection strategy and tools to be implemented
- Validate data from Konbit's current mapping database
- Identify and collect all relevant data on possible private sector entities in all activity areas but specifically those engaged in organizational strengthening
- Identify and collect all relevant data on possible international non-governmental organizations operating in the geographical areas

- Review similar existing mapping exercises from other organizations and incorporate relevant data
- Gather information from surveyed organizations on the type of capacity development assistance required, trainings needed and how Konbit can assist in strengthening their organizational structure

All deliverables—draft and final documents—should be sent to Konbit as an editable soft copy in English.

The firm shall share in advance the tools and instruments used develop for collecting information at country-level. The content of the mapping tool(s) will be developed with the relevant Konbit staff.

The firm will submit detailed work-plan at the inception of the assignment. Satisfactory completion of assignment will be measured against this work-plan and the expected deliverables mentioned above.

The firm will work closely with Konbit's Capacity Development Lead, the Monitoring and Evaluation Lead and the Chief of Party.

## **Timing and Level of Effort**

The level of effort shall not exceed <u>90 days or 720 hours</u> over a period not to exceed 120 days. Before starting on the verification of businesses in the field, the consultant shall deliver a first draft report with an analysis of existing documents, national surveys and reports that have been produced in connection with the mapping thematic area.

### **Qualifications and experience**

The firm must:

- Be legally registered in Haiti and locally owned
- Have relevant professional experience, with a proven track-record of conducting mapping studies at local and/or national levels
- Possess the ability to manage data and analysis using statistical programs like Excel in data management.
- Prove its ability to assess and analyze information from various sources
- Have excellent skills in producing succinct, clear materials in English
- Be well-organized with ability to adequately manage time and meet deadlines
